RESOLUTION 1

**RESOLVED**, that upon fully hearing the charges brought against the student who is the subject of student disciplinary case 2006-1, hereafter "Student 2006-1", and after giving full consideration to the testimony of all witnesses produced and all evidence presented, the Southern Columbia Area School Board has determined that Student 2006-1 is guilty of misconduct in the form of the charges detailed in the Hearing Notice and that such misconduct was disruptive of good order and in violation of law and the policy, rules and regulations pertaining to the conduct of students of the Southern Columbia Area School District.

## EXHIBIT B

### RESOLUTION 2

**RESOLVED**, that as a consequence of misconduct of Student 2006-1, as found by the Board, and pursuant to Section 1318 of the Public School Code, 24 P.S. § 13-1318, Student 2006-1 is hereby:

1. Expelled from the Southern Columbia Area School District until the commencement of the fourth marking period of the 2006-2007 school year scheduled to begin on or about March 30, 2007.
2. Prohibited from participating in any and all extra-curricular activities for the remainder of the 2006-2007 school year.

**RESOLVED FURTHER**, that the District shall provide an appropriate alternative educational placement for Student 2006-1 as soon as possible.

**RESOLVED FURTHER**, that written notice of this decision, together with appropriate Findings of Fact and Conclusions of Law consistent with the testimony and other evidence produced at the disciplinary hearing, shall be prepared by the Board's Counsel in accordance herewith, executed by the President of the Board and sent to Student 2006-1, with a copy to the parents of Student 2006-1.
