On a motion by Vought and second by Stahley, the nominations were closed. The motion carried by unanimous affirmative voice vote. Porter was elected Vice President by unanimous consent.

On a motion by Yocum and second by Porter, to designate Rick Steele as PSBA Liaison for the 2010 calendar year to serve as the district's contact for PSBA's governmental relations, was presented for approval. The primary responsibilities are to keep the board informed of developments in the Pennsylvania General Assembly, provide legislators with the Board's
